Loans must have at least six months payment history established and no delinquency in the past 180 days. Loans with extensions granted since loan inception may be ineligible for this offer. Collateral loans with ESA collateral premium (force-placed insurance) added by MPDCCU are ineligible for this offer.

Any loan with GAP insurance should be given special consideration. GAP insurance does have a term limit.
